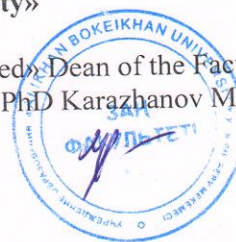



1 General provisions

On the basis of license No. 0064053 dated March 12, 2009, at the Faculty of Law of Alikhan Bokeikhan University, training is carried out with the assignment of the academic degree «Bachelor» to students in the specialty 6B12330 - «Law Enforcement».

The development plan for the educational program 6B12330 «Law Enforcement» was developed on the basis of the State Program for the Development of Education and Science of the Republic of Kazakhstan for 2020-2025, as well as in accordance with the Development Strategy of the educational institution «Alikhan Bokeikhan University» for 2020-2025.

EP 6B12330 «Law Enforcement» provides educational services aimed at training competitive and highly qualified specialists, taking into account the national priority of the state policy in the field of education, taking into account the strategy «Kazakhstan - 2050», based on the tasks set by the President of the Republic of Kazakhstan, the State Program for the Development of Education and science of the Republic of Kazakhstan for 2020-2025, as well as in accordance with the Development Strategy of Alikhan Bokeikhan University for 2020-2025.

EP 6B12330 «Law Enforcement» carries out educational activities in accordance with the Mission of the University: «Training of competitive personnel with higher education in a wide range of areas focused on the industrial and innovative development of the region»

The EP code 6B12330 «Law enforcement» corresponds to the classification in the field of education - 6B012 «National security and military affairs», in the direction - 6B123 «Public safety». This area is one of the special conditions for the implementation of high-quality education in the system of ensuring the national security of the state and society.

The exclusivity of the educational program 6B12330 «Law enforcement» lies in the fact that students in the process of studying scientific disciplines could apply the acquired knowledge, skills and abilities in a professional environment and defend their civic position to protect the rights, freedoms of citizens, the interests of society and the state, ensure public safety, and prevent criminal offenses. The peculiarity of EP 6B12330 - «Law enforcement activity» is that the studied legal disciplines are aimed at acquiring high-quality continuous and sustainable education by students revealing the main legal categories of law enforcement service in the Republic of Kazakhstan.

The relevance of EP 6B12330 - «Law enforcement» consists in the fact that it was not a specialized educational institution in the field of national and public security, OP successfully trains highly qualified specialists providing the human resources of law enforcement agencies and the judicial system in the Abai region «and in the Republic of Kazakhstan as a whole.

The main activity of the Educational Program «Law Enforcement» is the training of competitive specialists in the field of law enforcement.

In 2023, EP 6B12230-Law Enforcement, according to the ranking of the Chamber of Entrepreneurs «Atameken», in terms of the quality of education, took

2nd place among the universities of the Republic of Kazakhstan in the educational program «Law Enforcement».

The policy of the modular educational program (MEP), the catalog of elective disciplines (CED) EP 6B12330 - «Law enforcement» are aimed at constantly improving their image among consumers of educational services represented by students and social partners (employers). To individualize training and update EP 6B12330 «Law Enforcement» with the participation of leading teachers of the department, the dean of the faculty, as well as together with internal and external stakeholders, academic disciplines are systematically updated.

2 Analysis of the current situation and development trends of the labor market and educational services

Direction 1. Educational activities.

In the 2023/24 academic year, EP 6B12330 «Law Enforcement» was included in the register of educational programs of the Unified Management System for Higher Education of the Ministry of Education and Science of the Republic of Kazakhstan.

In accordance with the strategic plan for the development of the University, the organization of the educational process of EP 6B12330 «Law Enforcement» is based on the principle of continuity in the provision of special knowledge to students, taking into account judicial and investigative practice, changes in national legislation, as well as the ongoing state legal reform in the law enforcement system. On the basis of providing a material base, educational activities are carried out using innovative technologies, modern achievements of science and technology, which make it possible to improve the methods of teaching lectures, laboratory and practical classes.

To improve the quality of EP 6B12330 «Law Enforcement» at a meeting of the department, the faculty monitors the disciplines studied by students. Social partners, employers, graduates and students participate in the analysis of determining the demand for the studied legal disciplines and student satisfaction with the knowledge gained.

In order to effectively modernize the educational program, social partners are involved who carry out law enforcement activities in the person of law enforcement agencies and the judiciary: the Prosecutor's Office of the Abai region, the Department of Internal Affairs of the Abai region of the Ministry of Internal Affairs of the Republic of Kazakhstan, the Linear EP at st. Semey DP on transport of the Ministry of Internal Affairs of the Republic of Kazakhstan, transport prosecutor's office for the Abay region, Court No. 2 of the city of Semey of the Abay region, DCCES of the Abai region of the Ministry of Internal Affairs of the Republic of Kazakhstan.

Based on the opinions and wishes of internal and external stakeholders, EP 6B12330 «Law Enforcement» annually undergoes an external assessment by experts who are employees of law enforcement agencies and the judiciary of the Republic of Kazakhstan and have extensive experience in this field.

For the effective organization of the educational process according to the educational program 6B12330 - «Law enforcement», there are «Laboratory of pre-trial investigation», «Forensic laboratory», «Hall of educational trial», «Forensic training ground» of the SU DP of the Abai region, the circle «Young processualist» operates.

Laboratories are structural divisions of the Department of UPD. The key purpose of the «Pre-Trial Investigation Laboratory» and the «Forensic Laboratory» are:

- assist in the organizational and methodological support of lectures, practical classes using innovative technologies;
- practice-oriented lectures, practical and laboratory classes in special legal disciplines;
- the use of forensic technical means and methods to instill professional knowledge, skills and abilities in criminal law disciplines.

The courtroom is designed to provide information and educational and methodological support for the educational process and is aimed at forming the practical foundations of scientific knowledge, forming skills for conducting the main trial in accordance with the criminal procedure legislation of the Republic of Kazakhstan.

Within the framework of OP 6B12330 - «Law enforcement activities» there is a scientific research circle «Young processualist». The main purpose of the circle is to organize research and information and analytical work of students, to form motivation for research work, to instill in students the skills of independent research activities. The work of the circle is aimed at identifying and forming potential leaders, experts, analysts, young scientists; at mastering current issues of law enforcement by students. The scientific circle involves the development of legal culture, law-abiding behavior, the ability to build dialogues and discussions on various platforms, logical thinking, improve practical skills in judicial rhetoric, develop skills in working with normative legal acts, special and scientific literature. Current employees and veterans of law enforcement agencies, the judicial system, and the legal profession take part in the meetings of the scientific circle. Within the framework of the scientific circle, students are also trained to participate in interuniversity, national, and international scientific conferences, competitions, round tables, Olympiads, and demonstrative educational trials.

The entire educational process according to the educational program 6B12330 «Investigative and prosecutorial activities» is built in such a way that the student should receive stable, continuous and high-quality knowledge throughout the entire learning process. In order to objectively assess the theoretical knowledge and practical skills acquired, the educational process provides forms of control in the form of test tasks, oral, written and demonstration exams. In addition, students are evaluated by the State Attestation Commission, which involves practicing law enforcement officers and the judicial system.

According to the educational program 6B12330 «Law enforcement» in 2021-2022, the deputy head of the UP of Semey of the Abai region, Lieutenant Colonel Akhmetzhany Zh.A., in the 2022-23 academic year, the chairman of the SAC of the head of the SU DP of the Abai region of the Ministry of Internal Affairs of the Republic of Kazakhstan, Colonel Adilbekov S.M.

An important point of training is the subsequent employment of students. Monitoring of graduate employment is based on the national rating conducted by the National Chamber of Entrepreneurs «Atameken», the dynamics of employment of OP 6B12330 - «Law enforcement» in the first year after graduation: 2020 71%, 2021 - 60%, 2022 – 75.6%, 2023 – 73.5%.

One of the priorities in the process of employment of OP 6B12330 - «Law Enforcement» is the possibility of preparing students for professional certification. For the preparation of professional activities, conditions are purposefully created for the certification of students, the main goal of which is to prepare graduation courses for passing tests for knowledge of national legislation, the state language in the regional department of the Agency for Civil Service Affairs (ACSA) of the Abay region.

Certification preparation is carried out during the entire course of study. The implementation of professional certification is carried out systematically according to the approved curriculum with the active participation of the faculty of the department, employers. At the same time, the educational process relies on the use of interactive teaching methods, is organized taking into account mutual control and self-control of students, in preparing graduates for solving test tasks, situational tasks.

To solve the problems of employment of graduates of the EP 6B12330 «Law Enforcement», the faculty of the department, together with the dean's office of the Faculty of Law, with the employment center, the Center «Career» hold alumni fairs with the participation of social partners.

Strengths:

- Internal (teaching staff, students) and external stakeholders (social partners, employers) are involved in the development of the EP.

- Participation in the ratings of the Independent Agency for Quality Assurance in Education and the National Chamber of Entrepreneurs of the Republic of Kazakhstan «Atameken».

- Material and technical equipment that allows conducting classes using innovative technologies, creating conditions as close as possible to the conditions for committing a crime, the use of technical and forensic tools and methods for detecting and seizing trace information, analyzing the evidence base and using them to put forward an investigative version in the process of investigation and disclosure of a criminal offense.

Analysis of the main problems:

- The interaction of the teaching staff of the department and the law enforcement and judicial system of the Republic of Kazakhstan related to the improvement of the methodology of teaching practical and laboratory classes is not enough in full. This is due to objective circumstances, social partners, represented by law enforcement agencies, are burdened with the performance of functional duties, legal acts in the field of law enforcement are used only for official use, employees are burdened with a regime to observe state secrets and secrecy of the investigation.

- Low percentage of employment of students of EP 6B12330 - «Law enforcement».

Direction 2. Research activities.

Research activities of EP 6B12330 - «Law enforcement» are carried out on the basis of the legislation of the Republic of Kazakhstan and internal regulations of «Alikhan Bokeikhan University».

In order to form the research foundations of EP 6B12330 «Law Enforcement», the faculty of the department interacts with the Research Center (SIC) of the Faculty of Law: «Actual Problems of Jurisprudence». Within the framework of this center, research projects, round tables, international scientific and practical conferences aimed at popularizing the EP are being formed.

Planning, consideration and discussion of topical issues of EP 6B12330 «Law Enforcement» is carried out on the basis of promising topics of scientific

research of the department, are formed once every three years and are subject to state registration in JSC «NTSGNTE». For the 2022-2023 academic year, the approved topic is: «The main vectors for the modernization of law enforcement and judicial activities in the context of digitalization and sustainable development of society» (0122RKI0186).

As part of the improvement of this scientific direction, the faculty of the department annually conducts scientific and practical seminars, round tables.

On October 27, 2023, a meeting with forensic medical expert Shalaganov Bolat Fazylbekovich was organized for the participants of the student scientific circle «Young Processualist». During the meeting, topics such as the features of pathoanatomical examination, as well as conducting a forensic medical examination of a living person were discussed.

On November 03, 2023, at the Faculty of Law of Alikhan Bokeikhan University, as part of the activities of the student scientific circle «Young Processualists», students met with the head of the organizational and analytical department of the Investigative Department of the Semey Police Department of the Abai region Police Department, Police Major Yergalieva Assel Aydynkyzy. During the meeting, the specialist told future law enforcement officers how preliminary investigations in criminal cases are conducted, what is the peculiarity of operational work, shared her own experience in law enforcement agencies.

On November 16, 2023, the teaching staff of the Department of «Criminal Law Disciplines» of the Faculty of Law together with.

The Department for Combating Drug Addiction of the Regional Police Department Abai held a practical seminar for students «Prevention of drug crime among young people». The event was held as part of the promotion DEA Police Department «We are against drugs!» During the seminar, reports on measures to combat drug crime, tasks carried out by law enforcement officers in front of students were made:

November 28, 2023 at the Faculty of Law of Alikhan Bokeikhan The University held a round table on the topic «Criminal offenses in the field of informatization and communications», organized by the Department of Criminal Law-legal disciplines. The purpose of the event is to discuss issues of crime prevention in the field of informatization and communications.

The round table was attended by scientists, representatives of the judicial system and law enforcement agencies, including employees of the cyberpoll department of the Abai Region Police Department, lawyers and other social partners of the Faculty of Law, as well as undergraduates and students.

On December 1, 2023, a regional competition for educational trials in criminal cases was held at the ABU Faculty of Law among the students of the educational programs «Jurisprudence» and «Law enforcement» in higher educational institutions of the region Abai, Pavlodar and East Kazakhstan regions. The organizer of the competition was the Department of Criminal Law Disciplines of the Faculty of Law of Alikhan Bokeikhan University. For objective and impartial judging during the competition, law enforcement officers and the judicial system of the region were invited: judge of the regional court Berekbulov E.B., senior prosecutor of the Department for Supervision of the legality of the pre-trial investigation and criminal prosecution of the prosecutor's office of the region Abai Popova D.R. and the lawyer of the bar Association of the region Abai Adilbayev N.F. Also, a representative of the Commissioner for Human Rights for the region Abai took part in the judging Zhumageldin D.E. According to the results of the competition, the following students were awarded in various nominations:

- «The best judge» – Galieva Ayazhan (Toraigyrov University (Pavlodar);
- «The best Public Prosecutor» – Timur Akhmetzhanov (Toraigyrov University (Pavlodar);
- «The best side of defense» – Askerbekova Zhaina (Alikhan Bokeikhan University);
- «Best Role» – Talpynbek Aybarshyn (Alikhan Bokeikhan University).

The winner of the trial competition was the team «Jas processualist», representing Alikhan Bokeikhan University, the honorable II place was taken by the team «Pravo ToU» from Toraigyrov University of Pavlodar.

On December 13, 2023, the Faculty of the Department of Criminal Law Disciplines participated in the International Scientific and Practical Conference «Actual Problems of Law in the context of global challenges of our time», dedicated to the Day

Independence of the Republic of Kazakhstan.

The conference was attended by domestic and foreign scientists: V. A. Avdeev - Doctor of Law, Professor of the Department of Criminal Law and Criminal Procedure of the Law Institute of the Federal State Educational Institution of Higher Education «Yugorsky State University, Russia, Khanty-Mansiysk, O. A. Avdeeva - Doctor of Law, Professor of the Department of State and Legal Disciplines, East Siberian Institute of the Ministry of Internal Affairs Russian Federation, Irkutsk, K. B. Khakimov – PhD, Associate Professor, Tashkent State Law University, Head of the Department of Criminal Law, Criminology and Anti-Corruption, J. T. Murzabekova is a Doctor of Law, Professor of the Department of Civil and Labor Law at the Law Institute of the Kyrgyz National University named after J. Balasagyn, A.A.Chesnokov is a Candidate of Law, associate professor. Head of the Commission on Public Control of the Public Chamber of the Altai Territory, Associate Professor of the Department of Private Law of the Altai

branch of the RANEPА and the teaching staff of the ABU Law School. More than 50 participants participated in the international scientific and practical conference.

On December 19, 2023, the Department of Criminal Law Disciplines of the Faculty of Law of Alikhan Bokeikhan University and the Police Department of the Abai region discussed issues of professional training, the development of dual education and new joint projects. The Deputy head of the DP introduced the students to a new project of cooperation on training at the forensic training ground. Within the framework of the project, a memorandum on dual education was signed between the Police Department of the Abai region and the Department of Criminal Law Disciplines of the Faculty of Law of Alikhan Bokeikhan University. Deputy Head of the DP of the Abai region, Police Colonel E.D. Zakimov thanked the university administration for the well-coordinated work and high professionalism of the Faculty of Law.

University activists not only took part in the life of the university, but also contributed to the maintenance of public order along with the police of the region. Police Colonel E.D.Zakimov awarded distinguished students of the Faculty of Law Kaliev Daulet, Sarbiev Kuandyk, Yeshkenova Dilnaz and Slyamova Arai with thanks by letters. The university administration awarded the head of the DP region Abai, Police Major General B.J.Sultan, deputy head of the DP of the Abai region, police Colonel E.D.Zakimov, head of the investigative department of the DP of the Abai region, police Colonel S.M.Adilbekov with personalized breast medals for the contribution to the development of education

Faculty of Law of Alikhan Bokeikhan University. Leading teachers of the department, together with employees of the investigative divisions of the Department of Internal Affairs of the Republic of Kazakhstan, carry out research work within the circle «Young Processualist». This circle helps to consolidate the theoretical knowledge of students, as well as prepare scientific reports and get useful advice from mentors on problematic issues of the theory and practice of criminal justice.

As part of the development of dual education, students of EP 6B12330 - «Law enforcement» in the «Forensic training ground» of the Auezov EP DP Semey, the Department of Education of the Abai region of the Ministry of Internal Affairs of the Republic of Kazakhstan conduct practical classes, investigators, forensic experts. Conducting practical classes by employees of pre-trial investigation bodies helps to consolidate the theoretical foundations of the studied criminal law disciplines, as well as the acquisition by students of practical skills for the effective use of acquired knowledge and skills in practical activities.

In the specialized room «Training Hall of the Court Session», students, together with teachers, social partners, conduct scientific research on topical issues of the theory and practice of criminal justice. Based on the simulation of a mock trial for various categories of criminal offenses, students develop skills in judicial rhetoric, together with teachers and acting judges design the main trial in accordance with the criminal procedure legislation.

The main prerogatives of the faculty of the department are research activities aimed at the systematic involvement and participation of scientists and teachers, as

well as students in international practical conferences, round tables, olympiads.

The main criterion for the research activities of EP 6B12330 - «Law Enforcement» of increasing the publication activity of scientists, leading teachers of the department in publications recommended by the CQASES MES RK, scientific projects, textbooks, and other scientific works. Scientific work should contain relevance, high theoretical level, practical significance and close connection of the educational process with investigative and judicial practice, in order to contribute to the sustainable development of the Republic of Kazakhstan.

Strengths of the EP:

- Wide access to electronic resources for research activities. Encouragement and creation of conditions by the leadership of the university for the implementation of research activities of the teaching staff, as well as the provision of opportunities for studying in the magistracy, doctoral studies and defending a dissertation research in the Dissertation Council of «Alikhan Bokeikhan University»;

- Availability of an operating research center «Actual problems of jurisprudence»;

- Access to specialized databases of law enforcement agencies, as well as the relationship of trainees with practitioners.

Analysis of the main problems:

- low level of publication in publications included in the Scopus database; in publications recommended by the CQASES MES RK (in the state language, in English)

- the absence of a regional educational and methodological council (REMC) EP 6B12330 - “Law enforcement”, reflects research activities.

Direction 3. Educational activities

The priority task of EP 6B12330 «Law Enforcement» is to create conditions for the self-realization of students and the formation of their stable views and positions aimed at a high legal culture, respect for the honor and dignity of citizens. The university approved the Concept of educational work of the Kazakh Humanitarian-Legal Innovative University, which is a scientifically based set of views on the main goals, objectives, principles, content and directions of educational work.

The educational process of students of EP 6B12330 «Law Enforcement» is implemented through the institution of curatorship, the dean's office of the faculty, the teaching staff of the department of CLD, as well as through the bodies of Student self-government.

Student self-government is an integral part of the entire university management system and implements the most important functions of organizing student life. The activities of student self-government at the university are organized in accordance with the intra-university regulatory document «Regulations on the Committee for Youth Affairs».

The educational work of EP 6B12330 - «Law enforcement» is closely interconnected with student self-government and is implemented through such public organizations as: the creative group «Urker», the youth wing «Zhas Otan»,

the «Allikhan Bokeikhan University» Students Alliance, the public fund «Commonwealth of Young lawyers», “Union of KVN “Alikhan Bokeikhan University”»; debate club «Everest», charitable organization «Ak niet», «Business incubator» Parasattylyk mektebi.

The share of students involved in socially useful activities of EP 6B12330 - «Law enforcement»; of the total, 2019 - 55%, 2020 - 57%, 2021 - 59%; 2022 - 67.5% of those who took part in the events within the framework of the implementation of the «Tarbie Zhane Bilim» subprogram of the «Rukhani Zhangyru» program: 2017 - 60%, 2018 - 80%, 2019 - 90%; employed in sports sections, circles and creative associations: 2019 - 80%, 2020 - 83%, 2021 - 85%, 2022 -81.5%

To modernize the mechanisms for organizing educational activities, within the framework of the moral, psychological, cultural and recreational development of students, the university has created all the conditions.

In order to provide social and legal support to students, the University has a public fund «Commonwealth of Young Lawyers». Public Foundation «Commonwealth of Young Lawyers» implemented a number of socially significant projects.

Strengths:

- Availability of a system of autonomous student self-government
- The presence of the public fund «Commonwealth of Young Lawyers» which provides social and legal support to students.

Analysis of the main problems:

- weak participation in the republican student winter and summer sports olympiads, republican social and political events.

Direction 4. International activities

The main criterion for the development of OP 6B12330 «Law Enforcement» is the annual expansion of participation in the field of international cooperation, which is aimed at the implementation of academic mobility programs for students studying at foreign universities, the development of joint educational programs, as well as the use of international best practices in the field of education.

In 2023, as part of academic mobility programs, 2nd year student PD-202, OP 6B12330 «Law Enforcement» A.M. Bayekenov completed one semester of study (09/27/2022- 02/01/2024) at Bialystok State University (Poland, Bialystok)

To implement international academic mobility of students in 2023 at the university level 11 contracts were signed with leading universities of the near and far abroad.

In order to improve international academic mobility, OP 6B12330 «Law Enforcement» annually invites foreign scientists and specialists.

For the 2023/23 academic year OP 6B12330 «Law enforcement activities», lectures and practical classes are planned by scientists from the Republic of Belarus — Belokus State University - Minsk - Kalinin Sergey Arturovich; the Republic of Uzbekistan — Tashkent State Law University - Babayev Jahongir.

Strengths:

- Regular invitation of foreign scientists, specialists to give lectures for

students and teaching staff

Analysis of the main problems:

- Insufficient knowledge of English by the teaching staff and students of non-linguistic specialties;
- Insufficient funding for the development of academic mobility programs for students;
- Difficult geopolitical situation in the world associated with various local wars.

Direction 5. Resource provision

EP 6B12330 «Law Enforcement» has sufficient material, technical, information and library resources used to organize the learning process. The availability and level of the material and technical base is in the process of constant renewal and improvement. Creation of an effective education infrastructure is a prerequisite for the successful fulfillment of its mission by the University.

In order to implement the educational program, the following laboratories operate:

1) *Pre-trial laboratory*

This laboratory was created to assist in the organizational and methodological support of conducting classes using progressive and innovative teaching methods, creating conditions for conducting training sessions in special disciplines aimed at preparing students for practical activities that require them to have special knowledge, skills and abilities in areas of criminalistics.

2) *Crime Lab.*

The main goal of the Forensic Laboratory is to train qualified specialists with deep theoretical knowledge and practical skills in the field of forensic science using progressive teaching methods and forensic technology, computers and multimedia equipment.

3) *The training hall of court sessions* is intended for the implementation of information and educational and methodological support of the educational process and is aimed at developing practical skills and abilities.

4) *Office of the «School of Integrity»* as the main goal, it provides for the targeted training of young representatives of the anti-corruption movement of a new formation, the formation of an anti-corruption model of behavior among the youth, the education of integrity and academic honesty at the university.

5) *Research Center «Actual Problems of Jurisprudence»*. The Center carries out organizational and coordinating activities in the research direction of the development of the university unit on the basis of a long-term research plan.

6) The «forensic training ground» of the SU DP of the Abai region of the Ministry of Internal Affairs of the Republics. The center for forensic research was established on the basis of the Auezovsky OP UP in Semey DP of the Abai region. The main activity of the center is the retraining of young specialists – investigators of the Ministry of Internal Affairs of the Republic of Kazakhstan, conducting practical classes within the framework of dual education.

The university has a university library that provides teachers and students with the necessary information resources, basic and additional educational,

teaching and methodological literature for students of EP 6B12330 «Law Enforcement». The implementation of educational programs of higher and postgraduate education is ensured by students' free access to library funds, computer technologies, educational, methodological and scientific literature, educational, scientific, information databases, including international sources placed in electronic libraries. There are 35,516 textbooks, teaching aids in electronic form in the library of the university students of EP 6B12330 «Law Enforcement». There is also access to the following electronic resources of the library «ELSEVIER», «SPRINGER LINK», «THOMSON REUTERS (Web of Science)», «SCOPUS».

Strengths:

- Sufficient equipment of the appropriate material base for laboratory and research work.

Analysis of the main problems.

- development of educational and methodical publications of teaching staff in the state language;

- acquisition of published educational and methodological literature in English on the disciplines of the EP.

1.2 Financing of scientific infrastructure, creation of conditions for its development. Creation of the necessary conditions for maintaining the personnel potential of science, financing of research areas of teaching staff. Financing of publications in rating publications.

1.3 Improving the quality and effectiveness of scientific research and its potential for commercialization. Determination of development priorities and appropriate step-by-step measures to optimize the existing infrastructure. The completeness and consistency of the complex ensure the integrity and functional flexibility of the research potential at the national level.

1.4 Integration of EP into the international scientific space through the mechanisms of internationalization of education and science Increasing the main areas of cooperation of the EP with foreign countries, strengthening scientific ties with academies of sciences and other scientific organizations. Participation in scientific forums and work on joint research projects and grants.

Analyze legal and economic information, systematize safety standards for application in the professional activities of subjects of administrative, civil and labor law; ON 5 – legally correctly qualify the facts and circumstances related to the criminal case; ON 6- to implement the interaction of law enforcement agencies to protect the rights and freedoms of man and citizen in pre-trial and judicial proceedings in cases of various categories and types, to give the correct legal qualification of these acts; ON 7 - Make a legal procedural decision based on the results of the analysis of the investigative situation and model subsequent procedural actions and decisions; ON 8 - the ability to identify, prevent, disclose and investigate crimes and other criminal offenses, eliminate the causes and conditions that contribute to their commission; ON 9 – To know the essence and tasks of the criminal process of the Republic of Kazakhstan, the principles of the criminal process, the stages of the criminal process; master the techniques and methods of forensic techniques and tactics; ON 10 - analyze and solve legal problems of a theoretical and practical nature in the field of criminal prosecution and operational-search activities of law enforcement agencies; ON 11 – draw up an act of prosecutorial response, criminal procedural documents of pre-trial and judicial proceedings, including civil and administrative proceedings; ON 12 - apply the results of forensic examination in the course of criminal, administrative and civil proceedings; ON 13 – Know the main forensic tools and methods in the pre-trial investigation of criminal offenses, as well as cases of concluding a procedural agreement. Conceptual criminal law, criminal procedure and forensic knowledge of criminal proceedings; ON 14 - implement the acquired criminological and forensic knowledge, skills and abilities in the legal practice of criminal prosecution bodies, courts and other legal entities and individuals; ON 15 - mastering special computer programs and innovative technologies used in the legal field, including the provision of online advice to citizens and legal entities in criminal, civil and administrative cases.
