Program

ABU invites you to study for a double-degree educational master's degree program "Master of Business Administration" (MBA), implemented jointly with a European university - Varna University of Management (Bulgaria).

Varna University of Management (Bulgaria) is accredited by the National Assessment Agency and the Accreditation Agency of the Republic of Bulgaria, as well as the British Accreditation Council (BAC) and is one of the classified universities with a high SSRN rating, occupies the 168th position among the top 1000 best business schools in the world.

Upon completion of training, a master's student receives 2 diplomas: **a master's degree in ABU** in the chosen specialty and **a master's degree in MBA from Varna University of Management (European Master's degree)**.

The MBA degree is an international qualification in the field of business management.

An MBA is a special status, an elite international degree that will help to gain recognition from the professional community.

The knowledge and skills that a specialist receives while studying at the MBA program relate to various areas of modern business. The core of the program consists of subjects that develop key business skills: analytical thinking (accounting, economic policy, operations research, statistics, etc.), professional skills (financial management, HR management, operations management, etc.) and ethics (business ethics, corporate governance, etc.).

Learning conditions

Duration of training: 2 years

The form of training: full-time and distance

The language of instruction: English



The cost of the program depends on the chosen specialty at ABU

In case of choosing Master's degree programs of ABU such as:

- "Economics"
- "Finance"
- "Business Administration"

Tuition fee for the European program is 1950 euros for 2 years (975 euros per year).

In case of choosing Master's degree programs at ABU:

- "Computer Science"
- "Pedagogy and psychology"
- "Philology"

Tuition fee for the European program is 4000 euros for 2 years (2000 euros per year).
