Relevance of the research topic. Assessment of the prospects for the development of the economic efficiency of human capital in the healthcare sector of the Republic of Kazakhstan in modern conditions of society development is determined by the depth of knowledge of the relationship of all elements with the processes of demographic, economic and social development. The integral manifestation of the interaction of biological, social and economic properties of the population is the nature of the formation of human capital. In this regard, the healthcare strategy should be aimed primarily at the intensive formation of cost-effective human capital, and not at the development of individual elements of medical care. Development of qualitative characteristics of human capital in the field of healthcare ««strategy Kazakhstan's Way -2050 as a strategic goal of becoming one of the 30 most developed countries in the world through the new political course of the established state»

Healthcare is an important social sphere of society, since the results of medical activity are determined by changes in the development of the economy. That is, the state's healthcare strategy should be considered, first of all, not only as the development of individual elements of medical care, but also as the generation of a future income stream from the point of view of human capital, in particular social and hygienic. Accordingly, the development of a health strategy will increase the level of public health (fertility, mortality, morbidity, disability, etc.) of the development of human capital in the industry. b.) and necessitates the determination of the impact on the dynamics of individual socio—economic, demographic processes.

Currently, great importance is attached to human capital, as it helps to study many phenomena of market relations, to determine the effectiveness of invested funds in the human factor that determines the economic and social ability of society. That's why this area of healthcare deserves in-depth study. Determining the nature and patterns of the relationship between public health and human health is one of the main problems of medicine. To do this, it is necessary to change social and economic policies. The transformation of man into the main core of the modern economic system leads to profound changes in the content of economic concepts and the theory of socio-economic sciences. One of the most promising areas of development of the whole complex of these sciences in the XXI century is the concept of human capital.

Degree of scientific study of the dissertation work. Despite the importance of the dissertation research, there are practically no systematic theoretical approaches to the essence and significance of the problem posed so far based on the

implementation of these recommendations. That is, this gap is explained by the significant nature of the transition periods in the state. The issue of human capital development in the field of healthcare is one of the issues that should be addressed systematically in the state context.

The purpose of the study is to develop theoretical and methodological recommendations for the assessment and development of the economic efficiency of human capital in the healthcare sector of the Republic of Kazakhstan.

In connection with this goal , an attempt was made to solve the following tasks:

- To give the author's definition of the concept of "human capital", exploring the concepts of human capital and the history of economic development;
- Study, comparison of advanced foreign models for the development of human capital in the field of healthcare of the Republic of Kazakhstan;
- Conducting an assessment of the economic efficiency of the formation (development) of human capital in the healthcare sector of Kazakhstan;
 - Integral analysis of quality of life indicators in healthcare;
- Introduction of an economic and mathematical model and conceptual approaches to the development of the economic efficiency of human capital development in the field of healthcare, based on a balanced system of indicators;
- Development of proposals on priority state directions of human capital development in the healthcare sector of the Republic of Kazakhstan.

The object of the study is the development of human capital in the field of healthcare of the Republic of Kazakhstan.

The subject of the study is the assessment of the economic efficiency of human capital in healthcare and the definition and assessment of its development prospects.

Scientific novelty of the main provisions of the dissertation research:

- 3. analyze the main indicators of the development of healthcare in the Republic of Kazakhstan and evaluate the economic efficiency of the formation of human capital in this area;
- 4. development of methods for the integral assessment of indicators of the quality of life of the human capital of a healthcare organization; conducting an analysis in the field of healthcare using macroeconomic indicators recommended by WHO for the analysis of human capital;
- 5. expert assessment of state support measures in the development of human capital based on the use of a regression-correlation model in the healthcare sector of the Republic of Kazakhstan;
- 6. identify the main ways to improve the indicators of economic efficiency of human capital development in medical institutions and priority state directions of human capital development in the healthcare sector of the Republic of Kazakhstan.

The theoretical significance of the work is as follows: methods and organizational and economic mechanisms of human capital development in healthcare of the Republic of Kazakhstan are complementary to the theory of human capital development in healthcare.

The practical significance of the work is as follows: the results of the study can be used in the conditions of human capital development in the healthcare sector of the Republic of Kazakhstan. It has a methodical approach to evaluating the effectiveness of measures based on a balanced system of indicators of independent practical application.
