Explanatory note

The modular educational program (MOE) is compiled in accordance with:

- The State Standard of Higher and Postgraduate Education, approved by Order No. 2 of the Minister of Science and Higher Education of the Republic of Kazakhstan dated July 20, 2022;
- Rules of the organization of the educational process on credit technology of training, approved by the Order of the Minister of Education and Science of the Republic of Kazakhstan dated April 20, 2011 No. 152;
- Standard rules of activity of organizations of higher and (or) postgraduate education, approved by the Order of the Minister of Education and Science of the Republic of Kazakhstan dated October 30, 2018 No. 595;
- The Law of the Republic of Kazakhstan dated July 27, 2007 No. 319-III "On Education" (with amendments and additions as of 01.09.2022)
- Professional standard: Order of the Minister of Justice of the Republic of Kazakhstan dated March 27, 2017 No. 306.

The modular educational program (MEP) is designed as a set and sequence of educational modules for the entire period of study and is aimed at mastering the competencies necessary for awarding the degree "Bachelor of Law" according to the educational program 6B04220 – Jurisprudence.

The GED block includes disciplines (56 credits in total), during the study of which the graduate must master the competence of general education.

The BD block includes disciplines of the university component (UC), which is 40 credits, and elective components (EC), which is 71 credits. Modules of these disciplines allow you to form a complex of general professional competencies acquired by a graduate.

The PD block includes the disciplines of the university component (UC), which is 27 credits and the elective component (EC), which is 38 credits. Modules of these disciplines allow you to form a complex of special competencies acquired by a graduate.

Theoretical training - 232 credits, FD – 8 credits.

In total, the student must master 240 credits (100%) at the end of the MEP. In total, the MEP contains 19 modules.

The purpose of the training is the formation of professional skills that ensure the protection, guarantee of compliance with the legitimate rights and interests of the state, individuals, legal entities arising in the legal sphere; the ability to navigate the

system, structure of state, including legal bodies; interpret the norms of various branches of law; analyze, solve legal problems in the field of civil law, labor, administrative-legal, criminal-legal and other relations.

Expected results of the EP:

ON 1 - Demonstrate knowledge about the idea of a modern rule of law in order to instill skills of financial literacy, entrepreneurship, leadership, receptivity to innovation based on scientific research in compliance with the principles of academic integrity, as well as ensuring safety standards

ON 2 - Is able to interpret and apply national laws and international norms, have a detailed understanding of the legal regulation of a specific legal sphere, as well as ensuring compliance with the legislation of the Republic of Kazakhstan in the activities of state bodies and other subjects of law, as well as the implementation of professional activities based on developed legal awareness, legal thinking and legal culture, in compliance with the norms of professional ethics

ON 3 - Be able to formulate qualified legal opinions and consultations in specific types of legal activity, interpret the norms of civil legislation, transactions and contracts

ON 4 - It is legally correct to qualify facts and circumstances, as well as to navigate modern sources of enforcement proceedings, as well as to know the conditions and requirements for the level of competence of experts who have a qualification certificate for the right to conduct forensic examinations

ON 5 - Apply normative legal acts, implement the norms of substantive and procedural law in professional activity

ON 6 - Have the skills to prepare legal documents, correct and complete reflection of the results of professional activity in legal and other documentation, including the definition of ways to protect the rights of entrepreneurs, forms of legal responsibility, development of measures to prevent criminal offenses in the field of healthcare

ON 7 - the ability to identify, prevent, disclose and investigate criminal offenses, including eliminating the causes and conditions conducive to their commission using artificial intelligence

ON 8 - analyze and solve theoretical and practical legal problems in the field of financial, land, banking and other legal relations

ON 9 - to master the techniques and methods of forensic techniques and tactics, as well as, taking into account the current level of technology and scientific developments, to know and be able to analyze the current state and prospects for the development of forensic activities

ON 10 - to learn the practical application in the process of investigation and judicial review of criminal law and criminal procedure legislation

ON 11 - to understand the system of government bodies, the judicial system, the prosecutor's office, the system of law enforcement agencies, the bar and the notary

ON 12 - freely understand the labor legislation of the Republic of Kazakhstan and social security issues

ON 13 - be able to justify bringing to responsibility for environmental and administrative offenses

ON 14 - to uncover and establish the facts of offenses, determine the measures of responsibility for punishing the perpetrators, take the necessary measures to restore violated rights

ON 15 - Be able to use special computer programs and innovative technologies used in the legal field, including providing consulting assistance to citizens on issues of medical and social expertise online.

In order to create special conditions for people with special educational needs to receive education, the graduate's competence model is supplemented with professional competencies that ensure the adaptive nature of the main educational program. For this purpose, courses for the formation of the ability of persons with special educational needs to successfully socialize in society and actively adapt to the labor market, taking into account the characteristics of the disease, are introduced into the catalog of courses of the additional educational program "Minor".

The graduate's competence model

Classification of competencies of the educational program 6B04220 "Jurisprudence".
